September 30th, 2015 - If you get a section 21 notice it's the first step your landlord has to take to make you leave your home You won't have

May 10th, 2018 - The Tenancy Agreement clarifies the terms and conditions of the letting and avoids future misunderstandings over who is responsible for what in the property If the annual rent is below £100 000 and you DO NOT live in the premises the Tenancy agreement to be used is an Assured Shorthold Tenancy AST **'Renting from a private landlord Citizens Advice'**

January 14th, 1989 - Most private tenants will be assured shorthold tenants All tenancies that started from 28 February 1997 will automatically be assured shorthold tenancies ASTs even if there is no written tenancy agreement Tenancies that started between 15 January 1989 and 28 February 1997 will be ASTs if a'
